# Freedom of Information Act 2000

Dear

Thank you for the Freedom of Information Request you have made. I can confirm that the information you have requested is held by the Trust and our response is detailed below.

## Please can you tell me:

- How many children's homes there are in your local authority area?
- How many are local authority controlled and how many are private?
- How many are registered with Ofsted and how many are unregistered?

There are 89 children's homes currently operating in Birmingham, of which 5 are local authority controlled. All of the homes are registered with Ofsted.

## Please can you provide a list of the children's homes, including:

- Name
- Whether each one is local authority controlled and or privately controlled
- Address

Enclosed is a list of children's homes in the Birmingham area, which details the number of children that the homes is set up to take. Please note that the following homes are local authority controlled:

- Warwick House
- Charles House
- Edgewood Road
- Camborne House

Please note that the addresses have not been included as this constitutes personal data under the Data Protection Act 2018. As this is personal data, disclosure under the Freedom of Information Act 2000 (the Act) is conditional upon satisfying the First Data Protection Principle, that processing be fair, lawful and transparent.

We recognise that there is a public interest in transparency and accountability in public decision making. We have balanced this against the privacy rights of the individual data subjects and the fact that this act of processing would not be transparent to them. On balance, we consider the detriment to privacy through disclosure outweighs the interest that would be served. Accordingly, disclosure would be in contravention of the First Data Protection Principle.

It is therefore appropriate for us to withhold this information under section 40(2) of the Act by virtue of section 40(3A)(a). Therefore we are exempting this part of the request under section 40(2) of the Act by virtue of section 40(3A)(a) of the same Act.

Please can you provide a list of the children's homes, including:

- number of children living in each home
- how many children the council has placed in each home for each year over the past five calendar years
- how much money the council has spent on each placement
- how many children other councils (include name of council) have placed in each home for each year over the past five calendar years
- when each home was last inspected by the council, if applicable

The information you have requested is not held in a readily accessible format. I can confirm that the Trust has kept a manual record (i.e. outside of case management systems).

From undertaking a sampling exercise in respect to similar FoI requests in the past, we estimate that it takes approximately 20 minutes to locate the file and locate specific information contained in the file, dependent on the size and complexity of the file. In order for us to answer this question, there are 89 homes to review and we estimate that each one would take 20 minutes to review which would take 29 hours.

The Freedom of Information Act 2000 (the Act) requires us to comply with a request, unless it would be too expensive to do so. Under s.12 (Cost of compliance exceeds appropriate limit) of the Act, the cost limit for the Trust is  $\pounds450$  i.e. 18 hours at the rate of  $\pounds25$  per person per hour.

The cost limit allows us to consider when estimating the cost of complying with a request, time spent determining whether we hold the information requested; identifying, locating and retrieving it and extracting the information from the relevant documents.

We are therefore unable to process your request as to do so would exceed the cost limit as set out in s.12 of the Act. In cases where the time involved in dealing with requests for information would exceed 18 hours, the Trust normally offers individuals the option to pay for the additional work over and above 18 hours, at a subsidised rate of £25 per hour.

However, where the resources involved in dealing with a request would have detrimental impact on the Trust's ability to provide its core services, the Trust is entitled not provide this option, and accordingly, refuse the request outright. In this case due to the amount of work and resources required to comply with this element of your request, the Trust is of the view that the resources involved in

responding to your request, even if you were to pay the subsidised statutory rate of £25.00 per hour, would interfere significantly with the Trust's ability to provide its core services, as such, the Trust considers that it is appropriate to refuse the request outright on the basis of Section 12 of the Act.

If you are dissatisfied with our response to your request, you have the right to ask for an internal review. Internal review requests should be submitted within 40 working days from the date this authority issued its initial response. Please outline which part of the response you are not happy with setting out your reasons.
