Thank you for the Freedom of Information Request you have made. I can confirm that the information you have requested is held by the Trust and our response is detailed below.

- 1) The current level of demand for family assessment centres (e.g., number of referrals or assessments requested over the past 12 months).**

There were 23 referrals made in the period August 2024 to July 2025 with 21 placements made.

- 2) Whether there is currently a waiting list for family assessment centres, and if so, the number of families or individuals currently on the waiting list and the average waiting time.**

We do not have a waiting list.

- 3) The total number of placements made in family assessment centres during the calendar year 2024.**

In the calendar year 2024 we made 21 placements at Residential Family Centres.

- 4) The number of placements that were needed but could not be fulfilled in 2024, along with the reasons if recorded (e.g., lack of capacity, provider availability).**

There were no placements in 2024 that we were unable to fulfil.
